Meeting of Land of Sky Regional Council Board of Delegates June 25, 2016

Minutes

- I. <u>Call to Order</u> Chairwoman Mennella called the meeting to order at 1:00pm.
- II. <u>Invocation</u> The invocation was given by George Goosmann.
- III. <u>Pledge of Allegiance</u> All stood as the Chairwoman led the Delegates in the Pledge of Allegiance.
- IV. Roll Call The roll was called by George Goosmann. The following members were present: Denise Braine, Grady Hawkins, Larry Rogers, Matt Wechtel, Charlie Landreth, Gwen Wisler, George Goosmann, Jonathan Kanipe, Larry Harris, Anne Coletta, Bob Davy, Barbara Volk, Dona Mennella, Darhyl Boone, Patrick Fitzsimmons, Brenda Mills, John Mitchell, Shelia Norman (ph), George Morosani, Charles Dickens (ph), and Kathe Harris. The following guests were present: Stedman Smith. It was announced that a quorum was present.
- V. <u>Modification and Approval of Agenda</u> George Morosani moved to approved the Agenda with no modifications. Brenda Mills seconded the motion which carried without further discussion.
- VI. <u>Public Comment</u> -
 - A. <u>FY 2016/2017 Budget Hearing</u> Chairwoman Mennella opened the Public Hearing for the FY 2016/2017 Budget Ordinance. No public comment was received and the public hearing for the FY16/17 Budget Ordinance was closed.
- VII. <u>Recognition of Special Guests</u> Chairwoman Mennella recognized Matt Wechtel, Madison County Commissioner and alternate Delegate for the county to LOSRC's Board of Delegates.
- VIII. Chairman's Comments and Roundtable – John Mitchell –shared that Henderson County had its final budget hearing and the budget is passed in the county. There was a five cent increase in the property tax rate in order to purchase ambulances, provide for increases to deputies salaries, etc. A lot of capital projects are moving in Henderson County right now including the joint training facility for BRCC and Pardee Hospital. Planning is underway for a new Hendersonville hospital which will be placed where the current hospital is located. The county is going through the programming phase now to determine what that development will look like. Charlie Landreth- shared that the City of Brevard passed a budget that is revenue neutral- the property tax rate went up, but most property appraisals went down. Barbara Volk- shared that in the City of Hendersonville, Rhythm & Brews has moved to South Main Street and it's had its biggest crowd yet. Music on Friday nights and dancing will be starting up on Monday nights. Dona Mennella- shared that the Town of Laurel Park passed its budget and there was no increase in the tax rate. Jonathan Kanipe- shared that the Town of Biltmore Forest is sharing an intern with Laurel Park and he introduced Stedman Smith who also attends Appalachian State University. An architect has been selected for the Public Works Building and the July 4th picnic is coming up. Bob Davy- shared that the Town of Fletcher has passed its budget with no tax increase. Kathe Harris- announced that the Regional Aging Advisory Council is meeting in Transylvania County at Care Partners Adult Day Services on Thursday, July 18th. Brenda Mills- shared that part of her role with the City of Asheville is facilitating the Minority Business Program- for the upcoming fiscal year, funds have been allocated in the City's budget to provide for an Equity Program. The City is moving forward to look at equity in all areas. More details will be shared in the near future. Gwen Wisler- shared that the City of Asheville passed its budget with no increase in property taxes but some fee increases. The City is also looking at a Bond Referendum which if the City goes forward with that will be on the November ballot. Anne Coletta- shared that in the Village of Flat Rock the budget is passed with no tax increase; funds have also been provided to extend the trails in the park during the upcoming fiscal year and the ice cream social was a great success. Larry Harris- shared that the Town of Black Mountain passed its budget with no tax increase.

The Town is also busy with buildings going up. Patrick Fitzsimmons- shared that the Town of Weaverville passed its budget with a two-cent tax increase. Matt Wechtel- shared that Madison County will be passing its budget Thursday night and it is expected that will be done without any increase in taxes or fees. Also, the county is working on two significant projects within the school system- one is a new early college. Madison County is very proud of its early college program.

- IX. <u>Approval of Minutes from the May Regular Meeting</u> George Goosmann moved to approve the minutes of the June meeting as submitted. George Morosani seconded and the motion carried without further discussion.
- X. <u>Consideration and Approval of Consent Agenda Items</u> Consent Agenda items consisting of: A. June FY2016 Treasurer's Report were presented for consideration. Kathe Harris moved to approved the Consent Agenda as presented. Bob Davy seconded and the motion carried without further discussion.

A. FY 2016/2017 Budget Adoption – Justin Hembree shared that the proposed FY 2016/2017 Budget Ordinance has been distributed and it is the same budget that was presented at last month's meeting. He provided an overview of the total budget which included Revenue/Expenditure details for the entire organization- Aging Programs have the largest share of the funds that come into LOSRC. Workforce Development (WFD) and Economic and Community Development (ECD) funds are the next largest share of funds that come to the organization. As a regional COG, LOSRC has no taxing powers and the organization relies on federal and state funds. Operations for the organization are more of a direct budget- money in/money out through contracts or through the provision of programs operated directly by LOSRC. The one budget that fluctuates quite a bit from year to year is the ECD Department; some years there may a high level of grant funds. As grants go away, revenues and expenditures slow down. In response to a typo being pointed out, Justin Hembree communicated that if it is the Board's pleasure to approve the Budget Ordinance for FY16/17, the typo will be corrected.

Bob Davy moved to approve the FY 2016/2017 Budget Ordinance as presented. Kathe Harris seconded and the motion carried without further discussion.

XIV. Executive Director's Report -

- A. <u>July 27th Barbecue and Open House</u> Justin Hembree shared that there is not normally a Board of Delegates meeting in July. It has been awhile since the organization held an open house, now one is planned for July 27th. The event will begin at 12noon with a barbecue with the open house beginning at 2:00pm. Everybody is invited and the event is open to the public. It's planned to be a very casual event.

 B. <u>Introduction of New Staff</u> Erica Anderson introduced Linda Holt to the Board. Linda is the new Senior Community Service Employment Program (SCSEP) program coordinator.
