I tried to initiate a conversation with one resident in the hallway, but she walked past me without response.</p> <p>This facility is remote. Ms. Vaughn indicated that it is "not a place for someone who wants to be able to walk around the corner to the store." The Activities Director, whose name I did not get, and who only began working here in August, though she has abundant and varied experience in adult care, said she tries to schedule events that get residents off the grounds, including, for example, shopping trips, a boat ride on Lake Julian, a trip to the Vance Birthplace, a day at Lake Lure, etc.</p> <p>The facility is very clean.</p>

Mr. Vaughn said that the sign was there, in part, because of staff turnover and the ongoing need to inform new staff of this essential need of the resident in question. This reflects well on the way the facility is run.</p>
