This reduction in population allowed many remaining residents to have private rooms.</p> <p>When we arrived, several residents were sitting in a common room watching television or talking among themselves. Some were asleep. Others were walking up and down the hallways. One resident sat by herself on the front porch, "enjoying the view," she said.</p> <p>The consensus among the residents with whom we spoke was that Flesher's is a good place to live. A few residents indicated that the "food is not great"; but most seemed to be pleased enough with its quality. All agreed that there were sufficient amounts of food made available to them.</p>
