However, the activities for the month were posted outside her office and seemed quite comprehensive. Among the three of us we spoke to 5 residents, all all of whom seemed well cared for and happy with the Care Home.</p> <p>I spoke with Lisa, the Med Tech who stated that there were no crises, all was going well.</p> <p>At present there are 25 residents. There is one semi private empty and available.</p>
